Information for Sponsoring Organization

Registration Requirements

A sponsoring organization is required to register (Form GAB-11) with the appropriate filing officer, as defined in s.11.02, Stats., when it pays for the expenses for establishing, administering, or soliciting contributions for a separate segregated fund, often referred to as a political action committee (PAC). s.11.38 (1)(a)2., Stats. An organization is not required to register if the PAC promptly reimburses the organization for all expenses paid by its sponsor or if the PAC pays all its own expenses directly.

The sponsoring organization provides the name and address of the organization, and the name, complete address, and telephone number of a representative. **Campaign finance correspondence is mailed to the representative's name and address.** The sponsoring organization designates whether it is a Wisconsin or a nonresident organization. A nonresident organization does not maintain an office or street address in Wisconsin. The sponsoring organization also provides the name, address, and registration date of its separate segregated fund (PAC).

Nonresident organizations are required to file the name, mailing and street address of a designated agent within the state with the office of the Wisconsin Secretary of State, at 30 West Mifflin Street, 9th Floor, P.O. Box 7848, Madison, WI 53702.

Reporting Requirements

Sponsoring organizations are required to file campaign finance reports (Form GAB-12) twice a year. s.11.20, Stats. The July Continuing Report covers the period from January 1 to June 30 and must be filed no later than July 20. The January Continuing Report covers the period from July 1 to December 31 and must be filed no later than January 31 of the next calendar year.

A sponsoring organization reports the administrative and solicitation expenses it pays on behalf of its PAC. A nonresident organization is required to report only those expenses related to its activity in Wisconsin. s.11.38 (1) (a) 2., Stats.

A sponsoring organization is limited to a combined total of \$500 a year for solicitation of contributions for its PAC and for its conduit.
